

**BYLAWS OF  
LOVE 4 LIFE ASSOCIATION**

**ARTICLE I**  
**Name and Location**

**Section 1.1-Name**

The name of the Corporation is Love 4 Life Association (the Corporation).

**Section 1.2- Location**

The principal office of the Corporation, or the primary location where its business will be conducted, shall be in the City of Perris or the County of Riverside, or at such locations as the Board of Directors (“Board”) may determine from time to time.

**Section 1.3- Name and address of Corporation initial agent**

The name and address of the initial agent for the Corporation for service of process; is Wendy P. Romero at 3023 Avishan Dr., Perris, CA 92571.

**Section 1.4- Initial Street Address of Corporation**

The initial street address of this Corporation is 3023 Avishan Dr., Perris, CA 92571.

**ARTICLE II**  
**Purpose of organization**

**Section 2.1- Goals and Purposes**

- A) This Corporation is a nonprofit PUBLIC BENEFIT CORPORATION and is not organized for the private gain of any person. It is organized under the California Nonprofit Public Benefit Corporation Law for public and charitable purposes. In the context of such purpose, the specific purpose shall be:
- B) The specific purpose for which The Corporation is organized is to give support and inform children, young adults, adults, and the members of our community about bullying prevention, suicide prevention, and mental health. Through this we make conscious of these topics to others and prevent it from its negative consequences. Love 4 Life is open to any other issues that come up such as depression, stress, family problems, etc. that can be causing suicidal thoughts to individuals. The Love 4 Life members will be trained in order to communicate with community members about the different ways they can receive help. We are here to educate and listen to the children, teens and community, teaching them through different activities on how to accept each other and themselves. We believe that others are more likely to listen to people their own age and that our own teens can empower the new generations through the activities and resources we provide. We are promoting love through this organization and by this hoping to remove the stigmas that are causing bullying, cyberbullying, etc. Not only that, but trying to prevent suicide.
- C) The goal is to spread Love 4 Life at different high schools, colleges, and centers/groups in our community who will be using our program to promote our purpose with their schools and younger generations; using our activities and resources. Love 4 Life may be

present in college and community groups with local partnerships who then will be in charge of promoting our purpose at their school and visiting high school students to spread awareness of our mission. Any school with the Love 4 Life program will have to update the Love 4 Life Corporation on what they are doing; this is done simply and only to protect the teens and children in our community. Days and times of when the representatives at each school will have to update will be determined by the Board of Directors. All Love 4 Life chapters must be approved by the Board of Directors.

#### **Section 4.4 - Specific Powers**

**(c) The Board is in charge of any important decisions that are brought to the board, they are the only ones who can make big changes to the organization, more specific:**

**(i) Change in Love 4 Life Shirt Color, theme, branding, etc.**

**(ii) Change in Logo.**

**(iii) Change on the program.**

**(iv) The Board is able to decide whether it should be going through them and approve or denied, in order for any Love 4 Life representative to take action on their ideas.**

#### **Section 7.3 - Love 4 Life Extension Rules**

**Any Board approved Love 4 Life chapters shall follow these Bylaws in every way. More specific: (A) They must send a written report to the Board with their updates once a month. (B) They are not allowed to make any important decisions that can affect the corporation's name unless it is approved by the Board. (C) They must follow their local Love 4 Life board on assigning schools that they are attending to keep the Corporation organized. (D) They are not allowed to change the Corporation's name, logo, or programs. (E) With majority vote of the Board, we can resign a Love 4 Life chapter/ extension. (F) Love 4 Life leaders/representatives are able to resign, but must send a letter of resignation to Love 4 Life via email or mail. Love 4 Life is allowed to have the leaders/representatives sign a contract that they have been aware of these rules.**
